## IDIS Online 11.20.0 Release Notes

The next system release for IDIS Online (Release 11.20.0) will be implemented beginning on the evening of June 12, 2020. The following are the changes that will go live in the system on Monday, June 15, 2020 with this release:

### **COMMON**

- New grant source types "DW, EW, HW, MW, SW, UW, 1W" have been added to the Funding module to track commitments of CARES Act grant funds, differentiating COVID-19 related funds from FORMULA and COMPETITIVE grant funds.
- New grant source types "DW, EW, HW, MW, SW, UW, 1W" have been added to the Voucher module to track and differentiate disbursements of CARES Act grant funds from FORMULA and COMPETITIVE grant funds.
- Subgrant module has been restructured for screen performance.

#### **CONSOLIDATED PLAN**

• Updated the 'search by program year' dropdown menu to include the most recent years available for Consolidated Plans, Annual Action Plans, and CAPERs.

#### **CDBG**

- Require users to identify activities that will prevent, prepare for, and respond to the coronavirus.
- Receipt module has been enhanced to allow grantees to add program income receipts generated from CARES Act grant funds.
- Data Download options for Headquarters users updated to include the PR50, PR51, and PR54 data extract files.

#### **ESG**

- Grant functionality has been enhanced to track the 24-month Expenditure Deadline compliance for HESG grantees. Grantees will submit HESG Expenditure Deadline compliance remediation plans for flagged grants.
- Require Field Office users to review HESG Expenditure Deadline compliance remediation plans.
- Allow Headquarters users to view HESG Expenditure Deadline compliance explanations and remediation plans.
- For grantees, the Grant top navigation option will now display a numeric badge identifying the number of grants that have exceeded the 24-month Expenditure Deadline requirement.
- IDIS will send HESG Expenditure Deadline compliance notification emails to the ESG first and second grantee contacts, as well as to all active IDIS users with access to the HESG grant path.

#### **HOPWA**

- Receipt module has been enhanced to include source types to support CARES Act funding;
   allowing both Competitive and Formula grantees to add program income receipts generated from CARES Act grant funds.
- Approximate Cost Incurred Date voucher data field for CARES grant funds has been enhanced to ensure the earliest date allowed is December 1, 2019.
- Allow Competitive grantees to maintain the SU subfund.
- Allow Competitive grantees to subgrant grant funds to sponsor organizations carrying-out a project.
- Project module now requires users to identify projects being carried-out by sponsor organizations.
- New Project, Subgrant, and Funding rules have been implemented for five HOPWA-C pilot grants
  to track admin caps using updated subfunding, subgranting and funding mechanism. These pilot
  grants will use the newly implemented rules to limit funding of Project Sponsor Admin activities
  to 7% of the sponsor's annual subgrant amount and to restrict funding of Grantee Admin
  activities to AD fund types.
